## ORDER GRANTING PLAINTIFFS' MOTION FOR ATTORNEYS' FEES, LITIGATION EXPENSES, AND CASE CONTRIBUTION AWARDS

**THIS MATTER** having come before the Court on Plaintiffs' Motion for Attorneys' Fees, Litigation Expenses, and Case Contribution Awards filed on August 6, 2025; and

The Court having reviewed Plaintiffs' moving papers, including Plaintiffs' brief and supporting declarations, as well as the case file; and

Good cause having been shown, for the reasons expressed herein and as further set forth in the Court's Final Approval Order approving the parties' Settlement Agreement;

## IT IS ON THIS 8th DAY OF OCTOBER, 2025, HEREBY ORDERED, ADJUDGED AND DECREED:

- 1. Terms capitalized in this Order have the same meanings as those used in the Settlement Agreement.
- 2. The Notice Plan adequately and reasonably afforded Settlement Class Members the opportunity to respond to Plaintiffs' Motion for Attorneys' Fees, Litigation Expenses, and Case Contribution Awards. The Court has considered and rejected any objections timely and properly submitted.
  - 3. The Settlement confers substantial benefits on the Settlement Class Members.

4. Plaintiffs have submitted Declarations by Class Counsel in connection with

Plaintiffs' Motion for Attorneys' Fees, Expenses, and Service Awards that adequately document

Class Counsel's vigorous and effective pursuit of the claims of Plaintiffs and the Settlement Class

before this Court.

5. The Court finds the attorneys' fees in the amount of \$316,666.67 and litigation

expenses in the amount of \$14,392.36 to be fair and reasonable and within the range of attorneys'

fees ordinarily awarded in this District using a hybrid approach combining the lodestar method

and the percentage-of-recovery method. The Court finds that the expenses reported to the Court to

date were necessary, reasonable, and proper in the pursuit of this Litigation.

6. The Court, therefore, grants attorneys' fees and expenses in the amount of

\$316,666.67 in attorneys' fees and \$14,392.36 in litigation expenses. Defendants shall pay the

attorneys' fees and expenses in the time and manner specified in the Settlement Agreement.

7. The Court further finds that Plaintiffs David Bagenstose, Nitza Juarbe, Stacy

Moxley, Jason Richard, Diana Tracy, and Lisa Scaramuzzo (collectively "Plaintiffs") devoted

substantial time and energy to their duties. The Court therefore grants service awards in the amount

of \$5,000 Case Contribution Award for each of the Class Representatives for their contributions

in this case.
